Two photos – One full front showing height measurement with a suitable measuring device as described on certification form, one full side showing length of measurement with a suitable measuring device as described on the certification form. (Must be able to see feet also.) Must be current – within 30 days of application. (May submit third photo of any pose to be the photo used on CIDRA Certificate of Registration.)

**Please note: All photographs and pedigrees given to CIDRA shall be the sole property of CIDRA and can be reproduced or used in any way the CIDRA deems appropriate. No photographs will be returned.**

Optional items to submit with application:
