LITTER REGISTRATION APPLICATION

Both the sire and dam must be certified and registered with the CIDRA before the litter can be registered as **offspring** of Chinese Imperial Dogs. Once the puppy(s) reaches 14 months of age, they may then be certified and registered as Chinese Imperial Dogs if they fall within following requirements. All dogs must be certified by a veterinarian on our CIDRA certification form or two witnesses to weigh less than 9 pounds and be under 9" at the withers at 14 months or older to obtain final registration certificate. We reserve the right to withhold final certified registration papers if the dog does not meet the CIDRA criteria or if we find that the certification form was falsified. These conditions must be met in order to ensure the safety and wellbeing of our breeding stock and to ensure the consistency of the size we strive to maintain.
